**Explanation of Responses:**

- RSUs convert into common stock on a one-for-one basis.
- Represents the number of shares of common stock withheld by the Company to satisfy tax withholding requirements in connection with the RSU vesting.
- Represents the number of shares of common stock issued upon the vesting of an RSU plus the number of shares of common stock accrued with respect to such vested portion of the RSU as a result of dividend equivalent rights paid by the Company pursuant to the terms of the award.
- On February 1, 2013, the reporting person was granted 2,576 RSUs that vest in full on the third anniversary of the grant date.
- Represents only the RSUs granted on February 1, 2013 and does not include other RSUs with different vesting terms.
- On February 2, 2015, the reporting person was granted 5,882 RSUs that vest in three equal annual installments beginning on the first anniversary of the grant date.
- Represents only the RSUs granted on February 2, 2015 and does not include other RSUs with different vesting terms.
